The United Reformed Church Minutes of a meeting of Mission Council held 12-14 May 2017 at High Leigh, Hoddesdon, Hertfordshire

FRIDAY 12 MAY

Session 1

The meeting of Mission Council began at 1400, with worship led by the Moderators and their Chaplains. The Moderator, Mr Alan Yates, was in the chair and declared Mission Council open.

17/1 Paper M1 Minute Secretary May 2017

The Clerk, the Revd Michael Hopkins, proposed, and Mission Council agreed, unanimously, to appoint Andy Braunston as Minutes Secretary for this meeting of Mission Council.

17/2 Paper M1 Minute Secretary November 2017 onwards

The Clerk further proposed, and Mission Council agreed, unanimously, to appoint the Revd Ken Forbes as Minutes Secretary from November 2017, for the time being.

17/3 Facilitation Group

The General Secretary, the Revd John Proctor, proposed and Mission Council unanimously appointed the Revds Derrick Dzandu-Hedidor, David Herbert, Jenny Mills and Ruth Whitehead to be a Facilitation Group.

17/4 Minutes of the Meeting of Mission Council held 19-21 October 2016

These were unanimously accepted as an accurate record, and signed by the Moderator. There were no matters arising.

The General Secretary announced that it would soon be the 90th birthday of the Revd Bernard Thorogood, a former General Secretary, and Mission Council was invited to congratulate him by signing a card.

17/5 Paper X1 Our context for mission: The Scottish Church Census

The Revd Dr David Pickering, Moderator of the National Synod of Scotland, gave a presentation on the Scottish Church Census which gave a snapshot of Scottish Church life in 2016, showed trends in Scottish Church life between 2002 and 2016 and presented key outcomes of the census to Mission Council. Dr Pickering presented some selected insights for the URC arising from this report.

Mission Council adjourned at 3.20pm.

Session 2

Mission Council resumed at 4.05pm. The Moderator, the Revd Kevin Watson, was in the Chair.

The General Secretary noted that paper I9 was no longer to be tabled. Instead Ms Grace Pengelly would address Mission Council on the General Election.

17/6 Paper F1 The Wider Fold

Mission Council called for the report of the Faith and Order Committee. The Convenor, the Revd Elizabeth Welch, proposed the resolution in Paper F1. Following discussion, Ms Welch agreed to work with the Clerk, the Revd Professor Thompson, and Mr John Ellis to bring revised wording back to Mission Council later in the meeting, and the business was adjourned.

17/7 Paper F2 The Future of Membership

Ms Welch proposed the resolution in Paper F2. During discussion the General Secretary and the Revd James Breslin suggested removing the words "accepts the broad principles set out therein". However, this was not agreed, and the business was adjourned.

17/8 Paper I10 Our Context for Mission: The General Election

The Moderator invited the Mission Committee to address Mission Council. The Revd Bernie Collins, Convenor of the Mission Committee, introduced the Secretary for Church and Society, Ms Grace Pengelly, who gave a briefing about issues Christians should reflect upon in the run up to the 2017 General Election.

Mission Council warmly thanked Ms Pengelly for her work and that of the Joint Public Issues Team.

17/9 Paper H1 Further Thinking About Call

Mission Council called the report of the Ministries Committee. The Convenor, the Revd Paul Whittle, proposed the resolution in Paper H1.

Following discussion, Mission Council was unable to reach consensus, but was able to pass the resolutions recognising disagreement:

Mission Council supports the suggestion of a wider calling group and concurrence to specific spheres of
responsibility as normal practice, noting that in some cases ministerial responsibilities will be reviewed
and may be varied by mutual agreement and so with a fresh concurrence, while in others the same
responsibilities will be held for the duration of the ministry.

- 2. Mission Council instructs the Ministries Committee to consult widely, and to prepare proposals with regard to the required changes to the Basis of Union and to the Structure.
- 3. Mission Council instructs Ministries Committee to do further work on the practicalities of a change in the locus of call and concurrence, in particular with reference to manse provision and the vacancy candidating process.

17/10 Paper M3 Youth Representation in the Councils of the Church

The General Secretary formally proposed the resolution in paper M3. Mr Proctor noted that this had been agreed unanimously by General Assembly, and that no Synod had resolved that the matter be not proceeded with, so it now returned to Mission Council for a final vote.

Mission Council agreed the Resolution unanimously:

Acting on behalf of General Assembly, Mission Council gives final approval to the amendments to the Structure of the URC set out in Paper M3 of Mission Council May 2017.

The General Secretary reminded Mission Council that if members wished to remove any item from en bloc they should sign the appropriate form at the back of the hall.

Mission Council adjourned at 6.21pm.

Session 3

Mission Council reconvened at 8pm. The Moderator, Mr Alan Yates, was in the chair.

17/11 Paper Z1 Where is God calling the URC?

The Moderator invited the Revd Nicola Furley-Smith and the Revd Peter Meek to present paper Z1 on behalf of the Synod Moderators. Mission Council then broke into groups for discussion.

Mission Council adjourned at 9.15 pm with evening prayers led by the Chaplain.

SATURDAY 13 MAY

Session 4

Mission Council reconvened at 9.15am with morning prayers led by the Chaplain. The Moderator, the Revd Kevin Watson, was in the chair.

The General Secretary noted that that no requests had been made to remove items from en bloc. However, two items, M5 & J1, had been removed as they had been altered since the papers were circulated, and they would be taken, along with J2, later in the meeting.

17/12 Papers D1 and Y1 The Windermere Centre

The General Secretary noted that two alternative resolutions had been offered to Mission Council, and Mission Council would need to choose whether paper D1 or Y1 provides the substantive resolution.

The Moderator invited the Deputy General Secretary (Discipleship), the Revd Richard Church, to propose the resolutions in Paper D1.

The Moderator then invited the Revd Brian Jolly, Clerk of the North Western Synod, to propose the resolutions in Paper Y1.

After the proposals, members of Mission Council asked various questions for clarification.

Session 5

Mission Council reconvened at 11.15 am. The Moderator, Mr Alan Yates, was in the chair.

17/13 Paper B1 Our context for mission: commitment to God's creation

The Moderator invited the Moderator of the URC Youth Assembly, Mr Dan Morrell, to propose the resolution. During discussion, various members proposed, and Mission Council agreed, to amend the resolution so that the Mission and Communications Committees were instructed to work with the URC Youth Executive.

Mr Morrell responded to questions, and Mission Council agreed the resolutions by consensus:

- a) Mission Council commends the work already carried out by the Children's and Youth Work Committee, Children's and Youth Work Department, and the URC Youth Executive, in reducing the overall carbon footprint of the annual URC Youth programme.
- b) Mission Council warmly receives the document *Commitment to God's Creation*, adopted by URC Youth Assembly 2017, as a mandate for change.
- c) Mission Council instructs the Mission Committee and the Communications Committee to work collaboratively with the URC Youth Executive to advance this work and develop further ideas to get, particularly, children and young people involved in tackling climate change.

17/14 Papers J1 and J2 Nominations Committee Report

The Moderator invited Mrs Carol Rogers, alternate for the Convenor of the Nominations Committee, to propose the resolutions in papers J1 and J2, as amended on the Order Paper and verbally. The updated list is an appendix to these minutes. Mission Council agreed the resolutions by consensus:

- 1. Acting on behalf of General Assembly, Mission Council extends the tenure of the Revd Peter Meek as Moderator of East Midlands Synod for a further five years, until 31st August 2023.
- 2. Acting on behalf of General Assembly, Mission Council appoints the Revd Philip Brooks as Secretary for Ecumenical and Interfaith Relations from 1st July 2017 for an initial term of five years.
- 3. Acting on behalf of General Assembly, Mission Council appoints the list of nominations, as amended.

The Moderator thanked Mrs Rogers for her four years of service as Secretary of the Nominations Committee, and Mrs Rogers made suitable reply.

17/15 Paper M5 Updating Nominations Committee Rubric

The Clerk sought the permission of Mission Council to move the resolution in paper M5 in an amended form as had been notified on the Order Paper, the last sentence of paragraph 4 to read as follows:

'Any committee may invite other Assembly Officers (or their deputies) or staff members to attend in a non-voting capacity where the business so requires.' Mission Council accepted the amended form of words, and resolved by consensus:

Acting on behalf of General Assembly, Mission Council updates the rubrics of the Nominations Committee as set out in Paper M5 of Mission Council 2017.

17/16 Paper M4 Appeal, Reference and Constitutional Review

The General Secretary acted as Clerk for this item of business.

The Moderator invited the Clerk and the convenor of the Law and Polity Advisory Group, the Revd Professor David Thompson, to propose the resolutions in paper M4.

The Thames North Synod voted that the amendments to the Structure be not proceeded with, and the Clerk of the Thames North Synod, Mr Simon Fairnington, addressed Mission Council outlining their concerns.

The resolutions were put to the vote, and were both carried with one vote against, thus reaching the two-thirds majority needed to change the Structure:

- 1. Acting on behalf of General Assembly, Mission Council adopts the following amendments to the Structure to the URC:
 - 5. Appeal, Reference and Constitutional Review
 - 5.1. Any decision of a Church Meeting within an area of ecumenical experiment may be taken by way of appeal to the area meeting. A decision of any other Church Meeting may be taken by way of appeal to the synod on which the local church concerned is represented. Any decision of an ecumenical area meeting having implications for the United Reformed Church or any part thereof may be taken by way of appeal to the synod on which local churches in the area are represented. Any decision of a synod may be taken by way of appeal to the General Assembly.
 - 5.2. A Church Meeting may itself refer any dispute or difference arising within the local church for resolution by the synod. An ecumenical area meeting may refer any dispute or difference arising within the area for resolution by the synod. A synod may refer any dispute or difference arising within the province or nation under its oversight for resolution by the General Assembly.
 - 5.3. The synod may declare any decision of a Church Meeting within the province or nation under its oversight, or any decision of an ecumenical area meeting within that province or nation having implications for the United Reformed Church or any part thereof, which is (or has been reached by a procedure) incompatible with the Basis of Union, the Structure of the URC, the constitution of the ecumenical area (where applicable) or any rule or resolution of Assembly binding on the local church or the ecumenical area to be a nullity. The General Assembly may declare any decision of a Synod to be a nullity on analogous grounds. The review of any decision with a view to declaring it a nullity shall be known as constitutional review.
 - 5.4. Appeals, references and constitutional review under this paragraph shall be subject to conditions and processes laid down by the Assembly in Rules of Procedure. A wider council determining an appeal or reference may either substitute its own decision for that of the more local council, or remit the issue to the more local council for reconsideration. No procedure governed by this paragraph shall be used to review decisions reached under the ministerial disciplinary process or the incapacity procedure.
 - 5.5. The decision of the General Assembly on any matter which has come before it on appeal, reference or constitutional review shall be final and binding.
- 2. Acting on behalf of General Assembly, Mission Council makes the changes to the Rules of Procedure as set out in paper M4 of Mission Council May 2017.

17/17 Paper H2 Ministries Committee Deployment Formula

The Moderator invited the Revd Paul Whittle to propose the Resolutions. The Moderator explained that two alternative proposals are offered, and Mission Council was invited to choose Draft A or Draft B as the substantive resolution.

After discussion, Mission Council voted 40 for Draft A, and 23 for Draft B. Therefore, Draft A became the substantive resolution.

After further discussion, Mission Council, by an overwhelming majority, voted in favour of the resolution:

Mission Council, acting on behalf of General Assembly, agrees that stipendiary ministry posts, excluding those identified by General Assembly for CRCWs and Special Category Ministry, shall be allocated to

synods on the basis of a formula with a weighting of 60% for the number of members in each synod and 40% for the number of congregations in each synod. This formula shall be reapplied annually on the basis of the latest information available.

17/18 Paper X2 West Midlands Synod: Ministry in the Church

The Moderator invited the Revd Steve Faber, Moderator of West Midlands Synod, to propose the resolution in Paper X2. After discussion, the debate was adjourned.

The Moderator greeted Dr Jacqui Philips, the Clerk of the Church of England's General Synod, before she left the meeting, and Dr Philips made suitable reply.

Mission Council adjourned at 1 pm.

Session 6

Mission Council reconvened at 4 pm. The Moderator, the Revd Kevin Watson, was in the chair.

Mr Dan Morrell addressed Mission Council about the need to support Reform magazine.

17/19 En Bloc

The Moderator invited the General Secretary to move the various items which the Moderators had placed en bloc, which were passed by consensus:

Paper B2 Pilots Advocate

Mission Council supports the Children's and Youth Work Committee's decision to appoint a Pilots Advocate, which will be funded from the C&YW budget, and resolves that this post be filled through the Nominations Committee in the usual way.

Paper B3 Review of Children's and Youth Work

Mission Council accepts the need for a full review of children's and youth work in the URC, and directs the Children's and Youth Work Committee, the Head of Children's and Youth Work, and the DGS (Discipleship) to undertake such a review, the cost being met from the C&YW budget.

Paper F3 Faith and Order Committee - Report of ongoing work

No resolution.

Paper H3 Ministries updates

No resolution.

Paper G1 Financial Outcome 2016

No resolution.

Paper I2 Partnership Re-Commitment – Presbyterian Church of Ghana

- 1. Mission Council welcomes and affirms the Partnership Recommitment between the Presbyterian Church of Ghana, London and Europe Presbytery, and the United Reformed Church.
- 2. Mission Council recommends as good practice, and requests Church Meetings to consider seriously, the principle that an individual should not serve as an Elder in both of these churches simultaneously. This would not prevent an individual serving as an Elder in one denomination, and at a later time serving as an Elder in the other.

Paper T1 Ministerial Disciplinary Process

On the recommendation of the MIND Advisory Group and on behalf of General Assembly, Mission Council approves the changes to the Disciplinary Process set out in paper T1 of Mission Council May 2017 with immediate effect.

Paper U1 Task Group on the future of General Assembly – report

No resolution.

Mission Council expressed its appreciation of the people behind each of these resolutions and recognised the amount of time that had been involved in their preparation.

17/20 Paper D2 Westminster College Appointment of Tutor in Church History and Doctrine

The Moderator invited the Convenor of the Westminster College Board of Governors, the Revd Nigel Uden, to speak to the report. Mission Council noted that the Revd Dr Robert Pope had been appointed at Westminster College

17/21 Paper G4 Finance Committee New Treasurer Arrangements

The Moderator invited the honorary Treasurer, Mr John Ellis, to propose the resolution on paper G4.

Mission Council agreed by consensus:

Mission Council resolves to amend 2(a) (iii) of the URC Investment Committee's Terms of Reference to read: "the Treasurer or Deputy Treasurer of the United Reformed Church."

17/22 Paper I7 Mission Committee: World Council of Churches Glasgow Assembly Bid

The Moderator invited the Convenor of the Mission Committee and the Secretary for Ecumenical Relations to address Mission Council. Mission Council was informed that the AGM of Churches Together in Britain and Ireland had withdrawn their support for the bid for the WCC 2021 General Assembly to be in Glasgow. It was noted that the Churches in Germany were putting in a bid to host the Assembly in 2021.

17/23 Papers D1 & Y1 Future of the Windermere Centre

The proposers and seconders of the resolutions responded to questions and comments. Having ascertained that Mission Council was ready to vote on which was to provide the substantive resolution, the Moderator put it to the vote. There voted for Paper D1 41, and there voted for paper Y1 19. Mission Council had, therefore, chosen paper D1 as the substantive paper.

Following further discussion, the Moderator proposed that the resolutions be sent to the Facilitation Group so that a proposal based upon the discussion could be formulated.

17/24 Paper M6 Marriage of Same-sex Couples in Guernsey

The General Secretary proposed the Resolution in paper M6. Mission Council agreed by consensus:

Following the passing of Resolution 7 of the Assembly of 2016, Mission Council, acting on behalf of General Assembly:

- a) notes that under the Same-sex Marriage (Guernsey) Law 2016, the marriage of same-sex couples is now lawful in Guernsey;
- b) recognises that the competence and functions of the Church Meeting in Guernsey is no different from those of any other Church Meeting in the United Reformed Church;
- c) accepts that the definition and role of a "governing authority" in the Same-sex Marriage (Guernsey) Law 2016 are in essentials the same as those of a "governing authority" under section 26(A)(1) of the Marriage Act 1949 in England and Wales; and therefore
- d) declares, for the avoidance of doubt, that paragraph B of Resolution 7 applies to Church Meetings in Guernsey in the context of Guernsey legislation as it does to Church Meetings in England and Wales; and further
- e) directs that, in Guernsey, paragraphs C, E and F of Resolution 7 shall apply with the necessary modifications.

17/25 Paper Z1 Where is God Calling the URC?

The Moderator invited the Synod Moderators to give feedback from the small groups that met on Friday evening. The Synod Moderators noted that there were many and varied responses about what is or has been important to people: and a particularly positive response to things which allow churches to pick materials from a bank of ideas which meet a need when the time is right for them. Members of Mission Council had, however, found it harder to identify what we should give up, except for the fear of giving up itself. The Synod Moderators felt there was a need to establish some criteria to help shape our decision-making about what we should give up so we identify what is vital to our Church's life and what is a luxury or something which has served its purpose. Ecumenical engagement allows us to access a wider range of materials to support mission, focussed on Jesus - again we hear the words 'come back to my Son'. We can only engage where partners are willing – so ecumenism will look different in different places. The Synod Moderators felt there is a need to continue a conversation about these strategic questions.

Mission Council adjourned at 6.18 pm.

Session 7

Mission Council reconvened at 8 pm. The Moderator, Mr Alan Yates, was in the Chair.

17/26 Paper X2 West Midlands Synod: Stipendiary Ministry Numbers

Discussion resumed on Paper X2. During discussion, the Treasurer intimated that the sums required from reserves, were such a policy eventually to be agreed and implemented, would certainly take reserves below the minimum safe level agreed in the reserves policy within about five years, and would expend more than the totality of available reserves if continued for ten years. Upon being put to the vote, there were almost all blue cards shown, and only a handful of orange cards, so the resolution fell:

Mission Council asks the Finance and Ministries Committees to examine the implications of releasing sufficient money from reserves in order to maintain stipendiary ministry at the 2017 levels for the next

five years and the next ten years in order to promote growth, and to bring proposals to the November 2017 meeting of Mission Council.

17/27 Paper F1 Faith and Order: The Wider Fold

Discussion resumed upon paper F1. The Clerk reported some possible alternative wording to replace paragraph 2.3 of the draft scheme:

Isolated members may make their financial contribution to the URC through the church where their isolated membership is held or by direct gifts to the Ministry and Mission Fund.

Mission Council agreed this change.

After further discussion, the business was again adjourned.

17/28 Papers D1 & Y1 The future of the Windermere Centre

The Facilitation Group brought a suggested new resolution, which Mission Council was asked to reflect on overnight.

Mission Council adjourned at 9.15 pm after prayers led by the Chaplain.

SUNDAY 14 MAY

Session 8

Mission Council reconvened at 9.30 am. The Moderators and their chaplains led Mission Council in worship, which included the Sacrament of Holy Communion. Mission Council adjourned at 10.35 am.

Mission Council reconvened at 11 am. The Moderator, the Revd Kevin Watson was in the chair.

17/29 Paper F1 Faith and Order: The Wider Fold

After further discussion, during which compatibility with the Basis of Union was raised, the Moderator ruled under Standing Order 2.5.9.1 that the matters in paper F1 be adjourned to another time and place, authorising the Faith and Order Committee, either to bring back revised proposals to a future meeting, or not, as they might see fit.

17/30 Papers D1 & Y1 The future of the Windermere Centre

The Moderator invited the Revd Ruth Whitehead to present the Facilitation Group's resolutions.

After further discussion, Mission Council passed, recognising disagreement:

1. Mission Council, acting on behalf of General Assembly, resolves to close the Windermere Centre with effect from 25th May 2017.

Mission Council agreed, by consensus:

2: Mission Council, acting on behalf of General Assembly, expresses its gratitude to God and to all who have worked at the Windermere Centre for the contribution of the Centre over thirty years to the life, learning and fellowship of the United Reformed Church, and for its continuing legacy. It instructs the Education and Learning Committee to make appropriate arrangements for an act of thanksgiving and celebration for the life of the Centre.

Mission Council agreed, by consensus:

3. Mission Council, acting on behalf of General Assembly, directs the Education and Learning Committee to ensure that the staff of the Windermere Centre are offered practical and pastoral support at this time of change and loss.

Mission Council agreed, by consensus:

4. Mission Council sets a budget for the Windermere Centre's support from denominational funds for 2017 of £100,000.

Mission Council agreed, by consensus:

5. Mission Council, acting on behalf of General Assembly, supports in principle the sale of the Windermere Centre premises.

The honorary Treasurer assured Mission Council that the costs arising from physically separating the Centre part of the Windermere site from the Carver Uniting Church part of the site would be borne by the URC Trust.

After discussion, Mission Council passed, recognising disagreement:

- 6. Mission Council, acting on behalf of General Assembly, supports in principle the use of the proceeds of any disposal for lay development, and it:
 - a) believes that there is an increasingly apparent and urgent need for a viable, costed strategy for lay training and congregational development across the URC, and calls for the development of such a strategy;
 - b) agrees that this strategy needs to take account of existing lay training and development resources and opportunities available within and beyond the URC and needs to be sensitive to the varied geography and the uneven distribution of financial and human resources across the Synods;
 - c) asks the Education and Learning Committee to facilitate the development of this strategy, with the active involvement of relevant people from the Synods and the URC Resource Centres for Learning;
 - d) recognises that such training and development needs to be delivered in a variety of ways which are likely to include on-line, face to face and residential components; it must be easily accessible to all in the URC;
 - e) therefore, instructs the Education and Learning Committee to bring to Mission Council in March 2018 proposals for these proceeds to be used as a designated Lay Development Fund which will enable an outworking of the developed strategy.

The following member of Mission Council recorded their dissent to this resolution: Ms Morag McLintock

17/31 Paper F2 Faith and Order Committee: The Future of Membership

The Convenor brought an amended resolution, the wording of which was accepted for debate:

Mission Council receives the report of the Faith and Order committee on the future of Church membership in paper F2 of Mission Council May 2017, affirms the work that has been done to date and requests that the Faith and Order Committee undertake further work to develop these ideas, consulting with others as necessary, with the aim of working toward a common practice across the church in order to establish clarity and reduce current inconsistencies over how church membership is handled.

After discussion, further concerns were raised, and the Moderator ruled that Mission Council was not yet ready to make a decision on this business.
