Annual Safeguarding Returns

The online Annual Safeguarding Returns (ASR) are open for completion. We would kindly ask you to complete the return by 29 February, 2024 as it gives a fulsome picture of safeguarding in the denomination and how the safeguarding team can better support our churches in terms of training and guidance. We also ask that Local Ecumenical Partnerships that use the safeguarding process of another denomination also complete the ASR so that we are aware of any challenges in your churches.

Each Church Safeguarding Coordinator (primary contact) should have received log in instructions from their synod for the ASR. If not, please do contact your synod who will assist you in accessing the ASR or provide a blank hard copy of the form where you are unable to access or complete an online version.

We aim to keep the list of Church Safeguarding Coordinators up to date so we can communicate with you. Your Church Secretary has access to the United Reformed Church Update Portal which is accessible 24/7 to update details of Church Safeguarding Coordinators. Alternatively, they can contact their synod to ask them to make any changes that they need.



Children and Young People

Keeping Young People Safe in Private Dwellings is a guidance document produced by Churches Together in England and co-authored by a number of organisations including the United Reformed Church. It gives guidance to those working in children's ministry in private dwellings and is available at here bit.ly/3HmV7Mu to read and download.

A long time in the making and following a number of high-profile cases, the Online Safety Bill received Royal Assent on 26 October 2023. This piece of legislation covers broadly three areas protecting children online, shielding users from illicit content and helping adult users avoid harmful (but not illegal) content. This will be overseen by the Communication Ombudsman Ofcom. The legislation is complex and so the NSPCC has produced guidance on online safety which is available on their website: bit.ly/NSPCC-online-safety

Real Life Case Study from a Church Safeguarding Coordinator

The Church has a Pastoral Care Team which has oversight of a large team of Pastoral Visitors. These Pastoral Visitors are tasked with maintaining contact with church members and providing support and information when necessary. They also undergo training twice a year and have done, or are in the process of completing, the URC Basic and /or Intermediate Safeguarding training.

The church also has two Pastoral Care Elders who ensure that members, and those non-members who ask, have support from these Pastoral Visitors.

In our church, the two Pastoral Care Elders have, unusually, both been the Safeguarding Officers

The implementation of *GP6* has involved informing the whole church, that safeguarding is the job of all members, and this has been invaluable in raising awareness.

The following case will illustrate how a situation that arose was helped by a Pastoral Visitor alerting one of the Safeguarding Officers to a developing situation.

The concern was around a member's wellbeing and whether, or not, they were coping following a recent discharge from hospital. Attempts were made to contact the person by the Pastoral Visitor who then alerted the Safeguarding Officer for Adults at Risk. Serious concerns for the person's health, safety and well-being were identified and actions were taken to escalate the concern via the GP. We eventually learned from the member

themselves that the GP had instigated a process to ensure someone did a follow up welfare check.

The Church Safeguarding Officer, having contacted the Synod Safeguarding Officer, was advised on further follow up and suggested that when the Pastoral Visitor attempted to make contact it should be recorded, even if no contact was made. The SSO also advised checking with the church member what type of support was wanted and the frequency they would like to be contacted. Several other suggestions were made which have proved to be most helpful.

The *GP6* framework is helpful in raising safeguarding awareness across the church family and is invaluable for training purposes with Pastoral Visitors as it gives clear guidance. Having access to the Synod Safeguarding Officer is most helpful and supportive and enables both Safeguarding Officers at the church to receive objective and helpful, guidance and advice.
