## Spiritual Abuse Webinar

Wednesday 27<sup>th</sup> November 1.00pm – 3.00pm

We are delighted to be hosting a one-off webinar with Dr Lisa Oakley focusing on Spiritual Abuse.

Dr. Lisa Oakley is an Associate Professor at the University of Chester. She is also the Chair of the National working group for abuse linked to accusations of witchcraft and spirit possession and the Church of England Task and Finish Group on Spiritual Abuse and acted as a core participant to the independent inquiry into Child Sexual Abuse. Lisa has conducted research into issues of faith, safeguarding and abuse for the past 16 years. Her doctorate was on the topic of spiritual abuse and in 2013 she co-authored a book entitled *Breaking the Silence on Spiritual Abuse*. In 2019 a further book was published entitled *Escaping the Maze of Spiritual Abuse. Creating Healthy Christian Cultures*. Lisa has presented on these topics nationally and internationally. ## Update: National Synod of Wales



The National Synod of Wales has been working to align Synod Safeguarding training delivered in Wales with [Social Care Wales National Safeguarding Training Standards](#).

The revised training content will be delivered from November 2024 to URC churches across Wales.

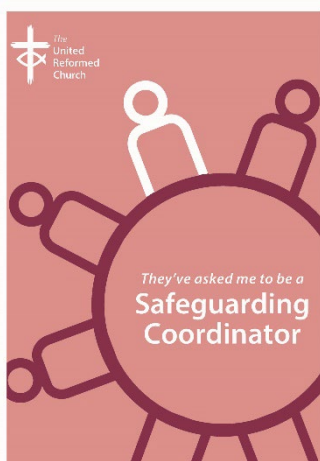
Alongside this, a Good Practice 6 Wales edition has been commissioned. The content of Good Practice 6 Wales edition is practically the same as the English edition, but there are terminology differences and reference to additional legislation which exists in Wales but not in England. It is hoped that the revised training content and Good Practice 6 Wales edition will serve the safeguarding needs of Welsh churches more effectively.

## Church Safety and Anti-Radicalisation

Public concerns about safety in public spaces, including churches, have increased, following terror attacks and numerous hate crimes. The URC now has a page on the website which offers support to churches on this area [Staying Safe in Church Buildings - United Reformed Church](#).

We would also encourage someone within your church to undertake the Government's free Prevent on line training which can be found at [Prevent duty training - GOV.UK \(www.gov.uk\)](#) If you have a concern about someone being radicalised in your church then please talk to you church safeguarding coordinator and they will seek the support of the synod safeguarding officer.

## Update to 'they've asked me to be a safeguarding coordinator'



'They've asked me to be a safeguarding coordinator' is written for those who may be considering whether to take on the role, and also for those who may have recently started. It summarises the main purposes of the role, the tasks involved and some of the skills required. It has now been updated and changes include:

- Setting out expectations in relation to training and getting a DBS check
- Explaining that contact details for CSCs will need to be stored in the URC database
- The need to ensure safeguarding is a regular agenda item for church and Elders' meetings
- Church safeguarding coordinators can now also act as DBS verifiers
- Reference to Good Practice 6

## Annual Safeguarding Returns

Each year Church Safeguarding Coordinators (CSC) are required to complete an annual safeguarding return which Synod Safeguarding Officers (SSO's) then collate and submit a report to the Designated Safeguarding Lead who then reports the findings to the General Assembly Safeguarding Committee. These reports provide the Synod and the denomination with invaluable data about safeguarding that is used to shape the support, training and policy development offered to synods.

Across the URC 84% of local churches completed the annual safeguarding returns for 2023, 100% of SSO's completed their annual reports. 96% of churches have a CSC which is a really positive step forward.

The annual returns show that 67% of churches include safeguarding as an item at elders meeting and 58% of churches have safeguarding as an item on church meetings.

So a reminder here that safeguarding should be reported on at least annually at your church and elders meetings, this is part of the URC's structure and details can be found [here](#) at point 10. In addition to this your church elders need to be aware and follow the Safer Election of Elder document [here](#).

Thank you to all those that completed their church return, the 2024 return should be landing in your inbox early next year!
